### Warranties - Copyright

I warrant to the *Associazione per la Ricerca, Innovazione e Scienze Sociali* (hereinafter ARISS), that:

1. the submission hereunder attached and delivered to ARISS (hereinafter, the "Contribution") is my original work, unless otherwise indicated;
2. the Contribution contains no violation of any existing copyright, or license, or duty of confidentiality, or any other third party rights. I further assert that the Contribution does not include any libelous or untrue statements and does not infringe any rights of others;
3. I have the full power and authority to enter into this Agreement and to convey the rights granted herein to ARISS, and to submit the Contribution for first publication in Global Politics Review and that my Contribution is not being considered for publication elsewhere and has not already been published elsewhere, either in printed or electronic form;
4. I have obtained and enclose all necessary permissions for the reproduction of any copyright works (including artistic works, e.g. illustrations, photographs, charts, maps, other visual material, etc.) contained in the Contribution and not owned by me and that I have acknowledged all the source(s);
5. I assign to ARISS, free of royalties and charge, the perpetual *non-exclusive right* to publish and distribute the Contribution, granting ARISS the right to publish and disseminate the Contribution through any kind of media and format and decide how and where to disseminate it. aforementioned warranties, ARISS shall indemnify and keep the author harmless against any loss or damages occasioned in consequence of such breach.

### **Declaration of Conflicting Interests**

### **Termination**

ARISS in its sole, absolute discretion, may determine that the Contribution should not be published in GPR. If such decision is taken, this Agreement shall be of no further force and effect, and neither you nor ARISS will have any obligation to the other with respect to the Contribution. In case of termination, ARISS will keep the Contribution and associated material strictly confidential, and it will not disclose nor share information about the Contribution and its Authors.

### **Counterparts; Facsimile**

This Agreement may be executed in counterparts each of which shall be deemed the original, all of which together shall constitute one and the same Agreement. A faxed copy shall be deemed as an original.

### **Governing Law; Arbitration**

The terms and conditions of this Publishing Agreement are governed by Italian law. Parties agree to attempt to resolve any dispute based upon, arising out of, or relating to this Publishing Agreement by mediation following the Mediation Rules of ADR Piemonte. If Parties cannot resolve their dispute by mediation, then the court of Torino (Italy) shall have exclusive jurisdiction.

**Contribution:** hereby identifies your submission to GPR in all its content (text, image and other content contained within the submission) and in all its versions (pre and post-peer-review).

**Copyright:** the set of exclusive rights granted to the author(s) of the Contribution, including the right to copy, distribute and adapt the work.

**License:** the rights and privileges that the copyright holder(s), via GPR, grants to someone else vis a vis something they have created.

By signing this Publishing Agreement, you retain ownership of the *copyright* of your Contribution and agree to a non-exclusive publishing contract with ARISS. This means that you retain the rights to publish the Contribution elsewhere, including commercially, because you are not subject to the conditions of ARISS/GPR's *license* to the public.

ARISS licenses your Contribution under a Creative Commons Attribution, Non-Commercial 4.0 International License (CC BY-NC 4.0). **Summary:**

- b. Authors can enter into separate, additional contractual arrangements for the non-exclusive distribution of the journal's published version of the work (e.g., post it to an institutional repository or publish it in a book), with an acknowledgment of its initial publication in GPR.
- c. Authors are permitted to post their work online (e.g., in institutional repositories or on their website), without charge or explicit permission from ARISS.
